Applications & Space Assignments:

All vendor applications will be carefully reviewed upon receipt. Vendors whose participation will be an enhancement to the festival will be invited to participate. Space assignments will be made in a manner that will ensure the viability of the festival and the diversity of the merchandise booth area. It is important for all the applicants to understand that acceptance is not guaranteed. Incomplete applications or those missing required permits will not be processed until all required items are submitted, including space fees and any applicable permits.

Selection of vendors is at the discretion of the BMJ manager. The manager reserves the right to refuse or assign space at any time. Space is assigned based on many factors including presentation/product appeal, type of vendor logistics etc. If application is accepted and space is not immediately available, vendors will be placed on a waiting list and contacted when an opening becomes available. All vendor merchandise MUST be PRE-APPROVED, no exceptions. Cancellation MUST be made 3 weeks prior for refunded deposit fee. Sharing booth space with other vendors is prohibited UNLESS pre-approved by the BMJ manager. Electricity is available free of charge. Your booth will be open and staffed throughout the festival hours of 1pm - 7pm, unless otherwise agreed and will not be dismantled until the specified time. All vendors are to provide their own booth and displays. The BMJ emphasizes environmental responsibility and encourages all vendors to keep your booths "Green". Please ensure that booth space is left clean of trash and all items are removed. **Please be prepared for inclement weather as the Blue Marble Jubilee is a rain or shine event.**

Additional information AND instructions will be sent to you upon acceptance of your application.

Please note that any photos, video or other publicity taken for the BMJ is property of the GVCSF and vendors and entertainers will not be compensated.
